Top 10 De-Escalation Tips for Health Care Professionals

According to the Crisis Prevention Institute, there are ten important tips to remember if you are working with a challenging patient or situation:

- 1.Be Empathetic and Nonjudgmental
- 2. Respect Personal Space
- 3. Allow Time for Decisions
- 4. Use Nonthreatening Non Verbal Body Language
- 5. Set Limits
- 6. Focus on Feelings
- 7. Ignore Challenging Questions
- 8. Avoid Over Reacting
- 9. Choose What You Insist Upon Wisely
- 10. Allow Silence for Reflection

EMS Education on Stroke and STEMI

In late December, our Cardiovascular team offered education to our Emergency Medical Services partners on recognizing and activating protocols for patients experiencing a stroke or heart attack. As an Advanced Comprehensive Stroke Center and designated STEMI (heart attack) receiving center, our Hospital has the expertise, infrastructure and interventional processes necessary to deliver specialized, lifesaving care to patients, leading to better survival rates and health outcomes.

The timing of this education was important - according to the American Heart Association, there are more deaths from heart attacks in the last week of December than at any other time during the year. Similarly, strokes are more likely to occur during the winter holiday months, between November and January.

Be sure you know the signs and symptoms of each, and what to do if you believe someone is experiencing a heart attack or a stroke – call 9-1-1 &

Common Signs and Symptoms of a Stroke

- Balance loss
- Eyesight changes
- Face drooping
- Arm weakness
- Speech difficulty
- Time to call 9-1-1

Common Signs and Symptoms of a Heart Attack


- Pain or discomfort in chest
- Lightheadedness, nausea or vomiting
- Jaw, neck or back pain
- Discomfort or pain in arm or shoulder
- Shortness of breath

The PVHMC Ethics Committee—Help with Difficult Issues

Did you know PVHMC has an Ethics Committee? Federal regulations and Joint Commission standards require all hospitals to have a process for addressing ethical issues that can arise in the care of patients. Associates of PVHMC, as well as our patients and their families sometimes face difficult healthcare decisions. If a patient is refusing treatment, do they have the capacity to make their own medical decisions? How can we identify a plan of care for an unconscious patient who has no one to speak for them? Should a patient in the final stage of a terminal disease be resuscitated if they stop breathing? When these kinds of questions arise, the PVHMC Ethics Committee is there to help.

The Ethics Committee provides guidance and discussion regarding the ethical aspects of the patient's care. Members of the Ethics Committee, including physicians, nurses, social workers, and community representatives are available to listen to concerns and help those involved to decide what is the best for our patients, while respecting the cultural and religious beliefs of all parties. When a patient is unable to take part in their own decisions, those involved in the patient's care may find it difficult to make decisions on that person's behalf, or they may disagree over what is in the patient's best interest. Family may see things differently than members of the medical team, or there may be conflict within the family itself. These are the times when the Ethics Committee can be of help.

The Ethics Committee does not make decisions for patients or families, nor does it force anyone to stop or start treatment. Instead, the Ethics Committee ensures good communication and facilitates respectful and productive discussions. Such discussions may help resolve disagreements and identify a plan of care for the patient going forward.

For instance, the Ethics Committee was recently asked to help in the case of an elderly female patient who was admitted for internal bleeding. The patient came from a facility where she had been in declining health for several years. Supported by a ventilator and feeding tube, the patient was non-communicative, with failing kidneys and chronic lung problems. Her treating physicians felt that making her as comfortable as possible should be the goal of care. She had no family or close friends, but the local Regional Center for developmentally delayed adults had been making medical decisions on her behalf. They requested input from the Ethics Committee before consenting for comfort measures. A meeting was convened with the treating team together with the Ethics Committee. All agreed with the physicians' recommendation for comfort-focused treatment and DNR, and that information was conveyed to the Regional Center. As a result, the patient was not subjected to further burdensome and ineffective treatment.

Members of the Ethics Committee also provide regular education on ethics-related topics, such as advance healthcare directives and POLST forms. And they help to formulate and clarify hospital policies. As an example, Ethics personnel were part of the effort to develop triage criteria to use in the event the Hospital had to invoke crisis standards of care due to the pandemic.

In these and other ways, the PVHMC Ethics Committee is a valuable resource.

You can also speak with Social Services or with the Risk Management/Patient Relations Office to obtain help from the Ethics Committee.

Password Complexity Notification

Dear PVHMC Associates.

In light of the escalating cybersecurity threats targeting healthcare organizations, Pomona Valley Hospital Medical Center (PVHMC) is reinforcing its commitment to safeguarding sensitive information. As part of our ongoing efforts to enhance security, we are increasing password complexity requirements to the protection of our systems and data.

Effective immediately, when resetting your PVHMC password, you will be required to adhere to the following password complexity criteria:

Complexity Requirements (4 out of 4):

- 1. Upper-case character
- 2. Lower-case character
- 3. At least one number
- 4. At least one special character !,@,#,\$,%,&,*,?

Additional Requirements:

- Minimum of 8 characters in length.
- Cannot use any of your previous 5 passwords.
- Cannot include any of the restricted terms such as:
 123, 2023, 2024, 2025, Pomona, Password, Spring, Summer, Winter

Please be advised that PVHMC_SelfService (pvhmc.org) will be sending you email on your account information. These communications are legitimate and are not phishing or spam.

For any user-profile or password changes, please visit our secure self-service portal at https://selfservice.pvhmc.org/. The site is only accessible while on Pomona Valley Hospital Medical Center and Offsite Campuses.

To ensure the effectiveness of these security measures, after resetting your PVHMC password, you must log out of all systems immediately. Please wait for a minimum of 5 minutes before signing back in to allow for the changes to take effect.




